Passing of Pioneers

Aaron Mercer of Scattle, one of the pioneers who crossed the plains 60' years ago, died there yesterday.

Thomas Mercer, an elder brother of Aarov Mercer, achieved distinction early in the history of Seattle, partly by bringing to the Pacific coast a shipload of young women who taught the pieneer schools and male the early homes of the territory. Many of these women still live on Paget Soun I and recall distinctly their long voyage sround Cape Horn. Thomas died in 1803. The principal island in Lake Washington is known as Mercer island because of the residence thero of the Mercer family.

Aaron Mercer Passes Away at Providence Hospital

Suffered a Slight Injury Last Week and in His Old Age the Shock Proved Fatal

In the death of Mr. Aaron Mercer at Providence Hospital this morning another name has been added to the roll of pioneers of this state who have passed away. For more than fifty years Mr. Mercer has made the Northwest his home. He was known by every old resident of this part of the country.

For five years Mr. Mercer was an invalid. Last week he fell at his home in South Park and broke a bone in his hip. He was taken at once to Providence Hospital, but the shock caused by the accident proved too great for a man of his years to overcome and he grew weaker until death relieved him early today.

Mr. Mercer was born in Ohio June 23, 1826, therefore being a little more than 76 years old at his death. He was a member of a large family, one of whom was Judge Thomas Mercer, one of the founders of the City of Seattle. Judge Mercer died here in May, 1896. In 1840 the Mercer family moved to Bureau County. Illinois.

In the early part of 1852 an immigrant train started from Princeton, Ill., for the Territory of Oregon. In it were Thomas Mercer, Daniel Bagley, Dexter Horton, William H. Shoudy and Aaron Mercer, all of whom, are well known in this city. These sturdy pioneers passed through the State of Iowa and crossed the Missouri River at a point where now stands the City of Omaha, which at that time was the very border between civilization and savagery. They followed the north bank of the Platte River to a point near its source and there crossed the Rocky Mountains, all the way undergoing trials and hardships that the men themselves alone know. Sickness and desolation did not impede the great task of these men. They kept on going until their destination was reached. - -----

Down the Columbia.

From South Pass in the Rockies, which they reached on July 4, 1852, these men proceeded by way of Fort Hall, Soda Springs, Bear and Green Rivers, on the north side of Snake River, through the valley to the Columbia River. They went down the Columbia in crude crafts to the Big Sandy country a few miles east of Portland. There they resumed wagon travel and in a few days reached Salem, Ore.

During that winter the men and their families remained in Salem. The next spring Thomas Mercer and Mr. Horton came to Seattle. Aaron Mercer remained in Oregon. Not long afterward his first wife died. In 1854 he married Miss Ann Stover, who survives, him. The wedding ceremony was performed by Rev. Daniel Bagley, now living in Seattle. and one of its best known citizens. From Salem the deceased went to the southern part of Oregon and engaged in gold mining, farming and trading. In 1864 he moxed with a large family to the State of Washington, settling near the race t rack, south of this city. He took a claim on the eastern shore 'of Lake Washington on Mercer Slough, which was named for him. Mercer Street in this city was named for Judge Thomas Mercer.

Mr. Mercer with his family moved to Eastern Washington where, at Ellensburg and other points, he was engaged for a number of years in the practice of medicine. He showed much skill as a nurse and was sent for for miles to attend to difficult cases. While at that time he held no physician's degree, he was called "Doctor." because of his great successes in handling cases in his own simple methods. It resulted in his actively engaging in the practice.

Lived at South Park.

Twenty years ago Mr. Mercer settled on a valuable farm six miles south of Renton. Elliott Station, on the Columbia & Puget Sound Railroad, is on that farm. Much of it has since been divided among his children. Old age and infirmities forced him to give up the farm and he moved to South Park, where he lived for the last few years.

Mr. Mercer leaves a widow. four daughters and five sons. They are Mrs. William Jordan. of Eastern Washington; Mrs. J. W. McAllister, of South Park; Mrs. J. W. Perringer. of Adams, Oregon; Mrs. M. Russell, of Seattle: W. H. Mercer. A. S. Mercer, A. L. Mercer. O. S. Mercer. all of Seattle, and J. D. Mercer, of Central Point. Oregon.


The date for the funeral has not been set. The body is now at Bonney & Stewart's.

Mr. Mercer was loved by all who knew him. His death is therefore a distinct loss. He was charitable always and willing to help whenever he could. He has been known to drive for miles to give some assistance to a sick person when he himself was ill. He was one of those sturdy pioneers from whom have sprung the men who do things: those who develop a country and make it what it is. Among the old pioneers there perhaps was not a man who was better known than Mr. Mercer.

SEATTLE PIONEER Called by Death

Mrs. Ann S. Mercer, One of City's Oldest Residents, Dies at Her Residence,

CAME HERE FROM OREGON

THE passing of Mrs. Ann Stoven Mercer, widow of Aaron Mercer. takes one of the oldest pioneers of Seattle and the state of Washington. Mrs. Mercer died Tuesday at her home at 8103 Eighth Ave. C., at the age of 79. Aaron Mercer was in the group of

PIONEER IS DEAD

William Mercer, 73, Passes On Duvall Ranch

SEATTLE, Dec. 9.—(U.P.)—Several hours elapsed after the death of William Mercer, 73, before authorities today learned that he was the scion of a distinguished family of Seattle pioneers.

Mercer died on his little ranch at Duvall last night, and his body was sent to the county morgue. Then deputy coroners learned that Mercer's father, Aaron Mercer, crossed the plains by oxcart on the epic blazing of the Oregon trail. Mercer island and Mercer avenue were named for the pioneer.

Further investigation disclosed that William Mercer, the eldest son, who was unmarried and lived alone, had four brothers, A. S. Mercer and A. L. Mercer, of Seattle; O. G. Mercer, of Montesano, and J. D. Mercer, of Hood River, Ore.; and two sisters, Mrs. L. M. Russell and Mrs. J. W. McAllister, of Seattle.

His brothers and sisters did not know of his death until authorities had learned his identity and notified them.
