Thomas Hart, who died at his residence in Polk county last week, was one of the old pioneers of this country. He came to Oregon in 1845, and settled on the place on which he died, having resided there constantly for near thirty years.

Your petitioner John P. Hart of said county and state respectfully showeth that Thomas Hart, the father of your said petitioner died at his place of residence in said county and state on, to wit, the 3d day of February AD 1874, intestate. That said intestate left real property (unreadable word?) in said county of the value of about five thousand dollars, and personal property of the value of about three thousand dollars aggregating about \$8000. That said intestate left a widow, Rachel Hart, aged about 64 years, residing in Polk Co, Ogn; a grand daughter Sally Bell (the sole heir of his daughter, Harriet, decd) aged about 35 years, residing in Gentry Co, Mo; three grand children, (the heirs of his son, Henry Hart, decd), to wit Thos Hart, aged about 35 years, Wm Hart, aged about 33 years, and Elizabeth E. Hart, aged about 30 years, all residing in Gentry Co, Mo; a daughter, Julia A. Hays, residing in Yola Co, Cal; a son H.B. Hart, aged about 55 years residing in Douglas Co,Ogn; three grand children (the heirs of his daughter Sarah Riggs, decd) to wit, W.M. Riggs, aged about 13 years, Thos Riggs, aged about 8 years and Arthur Riggs, aged about 3 years, all residing in Polk Co, Ogn; a son, Thos B. Hart, aged about 30 years, residence Polk Co and your petitioner, John P. Hart, son of deceased, aged about 27 years, residence Polk Co, Ogn.

That Rachel Hart, widow of said decd has executed her renunciation of her right to administer said estate of said intestate, and placed the same on file in this court, and recommending that your petitioner be appointed to administer said estate.

Therefore your petitioner asks that letters of Administration be issued to him in the (premises?).

Bartges Donation Claim No 43 in sections 7

and 18, in Township 22 S.R 7W; the Warren Sherwood Donation Claim No 44 in sections 7 and 18, in Township 22 S.R 7W and Claim No. 40 in sections 12 and 13 in Township 22 S.R 8W, the W ½ of the NW ¼ and Lot 2 of Section 7 Township 22 S.R. 7W, and Lots 1. 2, 3, 4, 5 of section 13, in Township 22 S.R. 8W, and containing the aggregate 680 acres, more or less: But it is expressly conditioned that the said devisees, in the event that they elect to accept this second bequest, shall fully pay and discharge the bequests hereinafter set forth, and if otherwise, the executrix hereinafter to be named, shall sell the said real property last described for the purpose of securing the funds with which to pay the said bequests hereinafter to be recited.

THIRD: I give, devise and bequeath to the heirs of my deceased sister, Harriet W. Smith, the sum of \$100.00

FOURTH: I give, devise and bequeath to the heirs of my deceased brother, Henry J. Hart, the sum of \$100.00

EIGHTH: I give, devise and bequeath unto Mary A. Stark and Anna M. Stark the sum of \$100.00 each.

NINTH: I give, devise and bequeath unto the said Mary A. Stark, the money, notes and accounts and all of the remainder of my personal property of which I may die seized.

TENTH: I hereby constitute and appoint Maggie N. Stark the sole Executrix of this my Last Will and Testament, to serve in said trust without bonds: and I hereby revoke and annul all former wills by me made, ratifying and confirming this and none other to be my Last Will and Testament.
